confirms the right to use the waters of UNNAMED TRIBUTARY OF INDIAN CREEK for IRRIGATION of 5.75 ACRES and SUPPLEMENTAL IRRIGATION OF 5.15 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Hood River County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 200. The date of priority is 1900.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and that the total quantity diverted during the irrigation season shall not exceed 3.0 acrefeet per acre, measured at the point of diversion.
