CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-6670. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL, IN THE SILVER LAKE BASIN

PURPOSE OR USE: IRRIGATION OF 3.0 ACRES

MAXIMUM RATE: 0.04 CUBIC FOOT PER SECOND

DATE OF PRIORITY: SEPTEMBER 23, 1974

The well is located as follows:

26 S	15 E	WM	33	NW NW	1320 FEET SOUTH AND 1320 FEET EAST FROM NW CORNER, SECTION 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use is as follows:

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point(s) of appropriation, shall not exceed the quantity of water available from the original point of appropriation described as follows:

Water use measurement:

- a. The water user shall maintain the meter, or other suitable measuring device as approved by the Director, in good working order at the point of appropriation.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

b. The water use shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.


The well at the point of appropriation shall be maintained to the well construction standards in effect as of May 10, 1991, and must include an access port.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION; PLACE OF USE approved by an order of the Water Resources Director entered November 6, 2012, at Special Order Volume 88, Page 695, approving Transfer Application T-11322, and together with Certificate 87831, supercedes Certificate 76038, State record of Water Right Certificates.
