CERTIFICATE OF WATER RIGHT

confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449.

SOURCE OF WATER: CROOKED RIVER, A TRIBUTARY OF DESCHUTES RIVER

PURPOSE OR USE: IRRIGATION OF 6.5 ACRES AND STOCK

MAXIMUM RATE: 0.11 CUBIC FOOT PER SECOND

DATE OF PRIORITY: 1891

The point of diversion is located as follows:

16 S	16 E	WM	18	NE SE	POD 4A – SEE MAP

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 6.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

Use under this right does not include domestic use. The domestic portion of the right was cancelled by an order of the Water Resources Director entered FEBRUARY 28, 2005, at Special Order Volume 63, Page 326, approving Transfer Application 6969.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available to the transferred rights at the original points of diversion described as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The right is subject to all other conditions and limitations contained in said decree.

The right to the use of water for the above purposes aforesaid is restricted to the lands or place of use described.

This certificate is issued to confirm changes in POINTS OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 28, 2005, at Special Order Volume 63, Page 326, approving Transfer Application 6969, and together with Certificate 80794, supersedes Certificate 68325, State Record of Water Right Certificates.
