CERTIFICATE OF WATER RIGHT

confirms the right to the use of waters perfected under the terms of Permit S-25991. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: CROOKED RIVER AND PRINEVILLE RESERVOIR, CONSTRUCTED UNDER PERMIT R-2223, TRIBUTARIES OF THE DESCHUTES RIVER

PURPOSE OR USE: IRRIGATION OF 99.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 76.1 ACRES

MAXIMUM RATE: 3.49 CUBIC FEET PER SECOND (CFS), BEING 1.02 CFS FROM POD 2A, 1.24 CFS FROM POD 4A, AND 1.23 CFS FROM POD 5A

DATE OF PRIORITY: APRIL 8, 1914

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from Prineville Reservoir and shall further be required to have a contract between the landowners and the United States Bureau of Reclamation.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.


Landowners shall further be required to have a contract with the Bureau of Reclamation.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to the use of water for the above purposes is restricted to beneficial use on the place of use described.

This certificate is issued to confirm changes in POINTS OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 28, 2005, at Special Order Volume 63, Page 326, approving Transfer Application 6969, and together with Certificate 80795, supersedes Certificate 75633, State Record of Water Right Certificates.
