## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of an UNNAMED STREAM, a tributary of OCHOCO CREEK, for SUPPLEMENTAL IRRIGATION OF 107.9 ACRES.

This right was perfected under Permit 23496. The date of priority is DECEMBER 10, 1954. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.37 CUBIC FEET PER SECOND, or the equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated and shall further be limited to a diversion not to exceed 4.0 ACRE FEET per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
