confirms the right to use the waters of BARNES BUTTE RESERVOIR, constructed under Application R-29611 and Permit R-1734, a tributary of OCHOCO CREEK, for SUPPLEMENTAL IRRIGATION OF 107.9 ACRES.

This right was perfected under Permit 23497. The date of priority is DECEMBER 10, 1954. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 293.1 ACRE FEET of stored water, or the equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to a diversion not to exceed 4.0 ACRE FEET per acre for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion not to exceed 293.1 ACRE FEET per year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
