confirms the right to use the waters of ONE WELL in the UMATILLA RIVER BASIN for SUPPLEMENTAL IRRIGATION OF 71.9 ACRES.

This right was perfected under Permit G-3530. The date of priority is MAY 24, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.65 CUBIC FEET PER SECOND FROM WELL #2; or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the rights allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The right allowed herein shall not authorize appropriation from the aquifer supplying those wells described in the State Engineer's Ground Water Report No. 11 as "Deep Wells in Basalt" unless appropriations are permitted in the Umatilla Basin Program, OAR 690-507-610 to 690-507-700 declaring the aquifer a critical ground water area.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
