ELH, LLC 76855 HWY 207 ECHO, OR 97828

confirms the right to use the waters of BUTTER CREEK, a tributary of the UMATILLA RIVER, for SUPPLEMENTAL IRRIGATION of 66.5 ACRES, AND STOCK WATER.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR in Volume 3, at Page 250. The date of priority is 1870.

The use is limited to 1.1 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the stream.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 4.0 acre-feet for each acre irrigated during the irrigation season of each year, from JANUARY 1 to SEPTEMBER 1, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.
