confirms the right to use the waters of BUTTER CREEK AND TRIBUTARIES, a tributary of the UMATILLA RIVER, for SUPPLEMENTAL IRRIGATION of 71.9 ACRES.

This right was perfected under Permit S-2102. The date of priority is JULY 2, 1914. The right is limited to not more than 0.84 CUBIC FEET PER SECOND; or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such a reasonable rotation system as may be ordered by the proper state officer.
