confirms the right to use the waters of A WELL in the SILVER CREEK BASIN for IRRIGATION of 245.1 ACRES.

This right was perfected under Permit G-9211. The date of priority is FEBRUARY 25, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.1 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
