## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, a tributary of WILLAMETTE RIVER for IRRIGATION OF 2.7 ACRES.

This right was perfected under Permit G-4085. The date of priority is APRIL 16, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.02 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed here and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
