CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGE W. EVANS
 RICHLAND, OREGON

Confirms the right to use the waters of Little Eagle Creek and Eagle Creek, a tributary of Powder River, for the purposes of irrigation of 163.35 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at page 291. The date of priority is 1868 for 5 acres; 1886 for 30 acres; 1881 for 128.35 acres.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second per acre, and shall be subject to all other conditions and limitations contained in said decree.

The points of diversion are located as follows:


