CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LOSTINE RIVER, TRIBUTARY TO WALLOWA RIVER for IRRIGATION OF 0.3 ACRES AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Page 177. The date of priority is 1883.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE AND ONE-HALF ACRE FEET per acre for any period of 30 days prior to July 31 of each year, and thereafter not to exceed ONE ACRE FOOT per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

The point of diversion is located as follows:



Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of Certificate 94327, State Record of Water Right Certificates, NOT MODIFIED by the provisions of an order of the Water Resources Director entered DEC 02 2019, approving Allocation of Conserved Water Application CW-111.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
