This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Page 177. The date of priority is 1883.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.35 CUBIC FEET PER SECOND, and is limited to ONE ACRE FOOT per acre for any period of 30 days prior to July 31 of each year, and thereafter not to exceed ONE ACRE FOOT per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.
