CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FULL CIRCLE PROPERTIES LLC 7785 ROCK HILL LANE CINCINNATI OH 45243

confirms the right to use the waters of West Fork of Williams Creek for irrigation of 48 acres, and Domestic and Stock use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1872.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.80 cubic foot per second.

The point of diversion is located as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter, or, with prior approval of the Director, another suitable measuring, in good working order at each new point of diversion.
- B. The water user shall allow the Watermaster access to the meter(s) or measuring device(s); provided however, where the meter(s) or measuring device(s) is/are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's (ODFW) operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that Oregon Water Resources Department (OWRD) regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of diversion together with that diverted at the original point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use herein described.

This certificate is issued to confirm changes in ADDITIONAL POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered APRIL 12, 2017, at Special Order Volume 104, Page 467, approving Transfer Application 12291, and corrected by an order of the Water Resources Director entered AUGUST 29, 2019, at Special Order Volume 113, Page 982, supersedes Certificate 16320, State Record of Water Right Certificates.
