CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of COLUMBIA RIVER, tributary of PACIFIC OCEAN, for IRRIGATION of 18.0 ACRES.

This right was perfected under Permit S-44511. The date of priority is MARCH 9, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.45 CUBIC FOOT PER SECOND (CFS), or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which such right is appurtenant, is as follows:

The quantity of water diverted at the point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion located in the SENE of Section 23, Township 5 North, Range 26 East, W.M.

The water user shall operate and maintain an approved fish screen at the new point of diversion. If Oregon Department of Fish and Wildlife (ODFW) determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use herein described and is subject to minim flows established by the Water Policy Review Board with an effective date prior to this right.

This certificate corrects scrivener's errors in the calculation of the total acreage and corresponding quantity from each point of diversion contained in Certificate 91006. This certificate describes that portion of the water right confirmed by Certificate 91006, State Record of Water Right Certificates, NOT MODIFIED by the provisions of an order of the Water Resources Director entered January 30, 2018, approving Allocation of Conserved Water Application CW-98, and together with Certificates 94864, 94867, and the Applicant's portion of conserved water under CW-98, supersedes Certificate 91006.
