## **CERTIFICATE OF WATER RIGHT**

confirms the right to use the waters of COLUMBIA RIVER, tributary of the PACIFIC OCEAN, for IRRIGATION of 58.4 ACRES.

This right was perfected under Permit S-43935. The date of priority is APRIL 6, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.97 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year, further limited to an annual volume of 175.2 acre-feet.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
