CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STANFIELD HUTTERIAN BRETHERN
36345 DESPAIN GULCH RD
STANFIELD OR 97875

confirms the right to use the waters of COLUMBIA RIVER, tributary of the PACIFIC OCEAN, for IRRIGATION of 58.4 ACRES.

This right was perfected under Permit S-43935. The date of priority is APRIL 6, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.97 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, further limited to an annual volume of 175.2 acre-feet.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which such right is appurtenant is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.



The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate describes that portion of the water right confirmed by Certificate 91008, State Record of Water Right Certificates, reduced in rate and duty by the provisions of an order of the Water Resources Director entered January 30, 2018, approving Allocation of Conserved Water Application CW-98, and together with Certificate 94867 and the Applicant's portion of conserved water under CW-98, supersedes Certificate 91008.
