The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.69 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
