CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KEVIN & CARRIE DUYCK TRUST 37995 NW HARRINGTON RD CORNELIUS, OR 97113

confirms the right to use the waters of WEST FORK DAIRY CREEK, a tributary of DAIRY CREEK, for SUPPLEMENTAL IRRIGATION OF 30.0 ACRES.

This right was perfected under Permit S-13388. The date of priority is DECEMBER 19, 1938. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.375 CUBIC FEET PER SECOND (CFS) FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The water user shall maintain the totalizing flow meter, or, with prior approval of the Direction, another suitable measuring device, in good working order at the point of diversion.

The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to clarify the point of diversion location, and to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 13, 2018, at Special Order Volume 108, Page 835 approving Transfer T-12840, and together with Certificate 93858, supersedes Certificate 81270, State Record of Water Right Certificates.
