 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FIDEL BROTHERS

confirms the right to use the waters of AN UNNAMED STREAM, SALT CREEK, & RESERVOIR CONSTRUCTED UNDER APPLICATION NO. R-45354 (PERMIT R-5378), a tributary of YAMHILL RIVER for the purpose of IRRIGATION of 263.1 ACRES and SUPPLEMENTAL IRRIGATION of 7.5 ACRES under Permit S-33951 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon, the priority of the right hereby confirmed dates from SEPTEMBER 5, 1968 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.98 CUBIC FEET PER SECOND (CFS), being 2.13 CFS from unnamed stream and 0.85 CFS from Salt Creek or its equivalent in case of rotation, measured at the points of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit No. R-5378 provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
