CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the NORTH YAMHILL RIVER, a tributary to the YAMHILL RIVER for the purpose of SUPPLEMENTAL IRRIGATION of 270.6 ACRES under Permit S-39919 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from MARCH 26, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.39 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion of the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as my be ordered by the proper state officer.
