## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JIM STEWART RT 6 BOX 1800 LAKEVIEW, OR 97630

confirms the right to use the waters of a SUMP in the COTTONWOOD CREEK BASIN for IRRIGATION 36.85 ACRES AND SUPPLEMENTAL IRRIGATION OF 14.45 ACRES.

This right was perfected under Permit G-9721. The date of priority is NOVEMBER 19, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.64 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the sump.

The sump is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH, of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
