confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN for IRRIGATION of 2.5 ACRES.

This right was perfected under Permit S-807. The date of priority is August 25, 1911. The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.031 CUBIC FOOT PER SECOND, if available at the original point of diversion; Hodgson and McBride Ditch or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

Prior to October 1, 2021, the water user shall install a weir or parshall flume, or, with prior approval of the Director, another suitable measuring device, at each new point of diversion..

Prior to October 1, 2021, the water user shall maintain and operate a fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
