CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the MILL CREEK BASIN, for IRRIGATION of 44.76 ACRES.

This right was perfected under Permit G-3529. The date of priority is JULY 12, 1967. The amount of water used to which this right is entitled is limited to the amount actually used beneficially, and shall not exceed 0.47 CUBIC FOOT PER SECOND, or its equivalent in the case of rotation, measured at the point of appropriation from the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at each point of appropriation. If the Director notifies the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period stated in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the watermaster access to the meters or measuring devices.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purposes aforesaid is restricted to the beneficial use on the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JUNE 7, 2011, at Special Order Volume 84, Page 440, approving Transfer Application T-8314, and together with Certificate 87093, supersedes Certificate 51395, State Record of Water Right Certificates.
