 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DRY MOUNTAIN RANCH LLC
 70194 SILVER CREEK RD
 RILEY OR 97758

confirms the right to use the waters of SILVER CREEK, tributary to HARNEY LAKE for IRRIGATION OF 19.6 ACRES AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Harney County. The decree is of record at Salem, in the Order Record of the State Engineer in Volume 12, at Page 298. The date of priority is 1877.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE-SIXTIETH of one cubic foot per second per acre irrigated from March 1 to April 30, and ONE-EIGHTIETH of one cubic foot per second from May 1 to August 1; provided, that the total quantity diverted during the months of March, April, May, and June shall not exceed 2.5 acre-feet per acre.

The point of diversion is located as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or another suitable measuring device as approved by the Director at each point of diversion in good working order.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 30, 2019, at Special Order Volume 112, Page 495, approving Transfer Application T-12827, and together with Certificate 94227, supersedes Certificate 14067, State Record of Water Right Certificates.
