CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SKI POND RANCH LLC 1775 WEST STATE STREET, #360 BOISE, ID 83702

confirms the right to use the waters of A WELL in the WHYCHUS CREEK BASIN for IRRIGATION OF 3.1 ACRES.

This right was perfected under Permit G-4841. The date of priority is AUGUST 25, 1970. The amount of water used to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.039 cubic foot per second.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meters or other suitable measuring devices approved by the Director at each point of appropriation in good working order.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use of the water shall be limited when it interferes with any prior surface or ground water rights.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JULY 18, 2016, at Special Order Volume 101, Page 437, approving Transfer Application T-12188, and together with Certificate 91703, supersedes Certificate 87345, State Record of Water Right Certificates.
