CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CRESCENT LAKE RESERVOIR (CONSTRUCTED UNDER PERMIT R-2744), a tributary of CRESCENT CREEK and LITTLE DESCHUTES RIVER, for SUPPLEMENTAL USE ON
7329.23 ACRES OF IRRIGATION (IS)
21.14 ACRES OF INCHOATE IRRIGATION (IS), AND
16.2 ACRES-EQUIVALENT OF POND MAINTENANCE (PMS).

This right was perfected under Permit S-27841. The date of priority is DECEMBER 8, 1961.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 42,727 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


