CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of DEAD INDIAN CREEK, a tributary of SO. FORK LITTLE BUTTE CREEK, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The dates of priority are 1858 and 1888. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 2.41 CUBIC FOOT PER SECOND (CFS), being 1.23 CFS under 1858 priority and 1.18 CFS under 1888 priority, from May 1 through September 30.

The description of the stream reach in which flows are to be maintained is as follows:

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 17204, and any related decree.

This certificate is issued to confirm a change in use and place of use approved by an order of the Water Resources Director recorded in Special Order Volume 117, Page 251, approving Transfer T-13177, and along with Certificate 95222 supersedes Certificate 17204, State Record of Water Right Certificates.
