CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LAKE CREEK, a tributary of the METOLIUS RIVER for IRRIGATION, LIVESTOCK AND DOMESTIC USE ON 49.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jefferson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is 1888.

The use is limited to 3.0 acre-feet per acre, measured at the point of diversion from the stream, which may be diverted at a rate of not to exceed 1/60th cubic foot per second per acre during the irrigation season from May 1 to September 15, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
