CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TERRY VANDEVER
HC 60, BOX 3370
LAKEVIEW, OR 97630

confirms the right to use the waters of ONE WELL a tributary of MILL CREEK for IRRIGATION of 87.3 ACRES.

This right was perfected under Permit G-7697. The date of priority is JULY 27, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.09 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this rights and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


