When required by the Department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered DECEMBER 21, 2011, at Special Order Volume 85, Page 839, approving Transfer Application T-10425, and together with Certificate 87333, supersedes Certificate 83670, State Record of Water Right Certificates.
