CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E. C. FARR
OLEX, OR

confirms the right to use the waters of ROCK CREEK, for the purpose of IRRIGATION of 27.6 ACRES, and SUPPLEMENTAL IRRIGATION OF 28.0 ACRES, DOMESTIC AND STOCK.

This right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County and the said decree entered of record at Salem, in the Order Record of the State Engineer in Volume 15, at Page 461. The priority of the right thereby confirmed dates from 1894.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 CUBIC FOOT PER SECOND PER ACRE irrigated to JUNE 1 and 1/80 CUBIC FOOT PER SECOND PER ACRE thereafter; further limited to 1.0 ACRE-FOOT per calendar month to JUNE 1 and 4.0 ACRE-FEET PER ACRE during season APRIL 1 to SEPTEMBER 30; measured at the point of diversion.

A description of the lands irrigated under such right, to which the water is appurtenant (or, if for other purposes, the place of use where such water is put to beneficial use), is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to describe the right modified by provisions of an order of the Water Resources Director entered NOV 06 2020 and recorded at Special Order Volume 117, Page 805-806, approving a partial diminution of the right evidenced by Certificate 25159, State Record of Water Right Certificates. This certificate supersedes Certificate 25159.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
