CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-730. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL A TRIBUTARY OF LOST RIVER

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 32.4 ACRES

MAXIMUM RATE: 0.30 CUBIC FOOT PER SECOND

DATE OF PRIORITY: DECEMBER 11, 1957

The well is located as follows:

40 S	12 E	WM	34	SE SW	WELL 1 - 1125 FEET NORTH AND 450 FEET WEST FROM S1/4 CORNER, SECTION 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by a proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available from the original points of appropriation described as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered November 7, 2011, at Special Order Volume 85, Page 632, approving Transfer Application T-11185, and together with Certificate 87780, supercedes Certificate 30279, State record of Water Right Certificates.
