confirms the right to use the waters of EIGHT MILE CREEK, A TRIBUTARY OF FIFTEEN MILE CREEK AND TWO LARGE SPRINGS IN NW1/4 SW1/4 SECTION 28, T 1 N, R 14 E, WM for IRRIGATION of 19.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 406. The date of priority is 1885.

The points of diversion are located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
1 N	14 E	WM	28	NW SW	EXISTING - 500' EAST AND 1150' SOUTH OF W1/4, SECTION 28
1 N	14 E	WM	28	NE SW	ADDITIONAL - 880 FEET SOUTH AND 1360 FEET EAST FROM W1/4 CORNER, SECTION 28

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre-feet per acre in any irrigation season.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q	Acres
1 N	14 E	WM	28	NE SW	12.8
1 N	14 E	WM	28	NW SW	6.4

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered January 27, 2003, at Special Order Volume 57, Page 64, approving Transfer Application T-8736, supercedes Certificate 5645, State record of Water Right Certificates.
