confirms the right to the use of water perfected under the terms of Permit S-259. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: STRAWBERRY CREEK, A TRIBUTARY OF JOHN DAY RIVER

PURPOSE OR USE: IRRIGATION OF 51.0 ACRES

MAXIMUM RATE: 0.64 CUBIC FOOT PER SECOND

DATE OF PRIORITY: MARCH 5, 1910

The point of diversion is located as follows:

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q	Acres
13 S	34 E	WM	33	NW NW	26.8
13 S	34 E	WM	33	SW NW	24.2

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or measuring devices in good working order, at each point of diversion (new and existing).
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.



NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
