## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRED B. GRABHORN RT 1 BEAVERTON, OR

confirms the right to use the waters of an UNNAMED CREEK, a tributary the TUALATIN RIVER, for IRRIGATION of 11.5 ACRES.

This right was perfected under Permit S-21968. The date of priority is December 4, 1952. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.144 cubic foot per second or its equivalent, in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Land on which water is to be used is part of that described as follows: Beg. at a point 500 ft. W. of the NE cor. of Sec. 12, T 2 S, R 2 W, W.M. in Washington County, State of Oregon, thence continuing S.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
