## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

TYGH VALLEY HIGHLINE DITCH COMPANY TYGH VALLEY, OR 97063

confirms the right to use the waters of BADGER AND TYGH CREEKS, a tributary of WHITE RIVER for irrigation of 65.0 ACRES.

This right was perfected under Permit S-19086. The date of priority is OCTOBER 24, 1949. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.25 CUBIC FEET PER SECOND, water to be diverted from Tygh Creek when available, any deficiency in the available supply from Tygh Creek to be made up by diversion from Badger Creek providing the total diversion does not exceed 1.25 cubic feet per second from both streams.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acrefeet per acre for each acre irrigated during the irrigation season of each year, provided further that the total diversion from both sources shall not exceed the quantity allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
