NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION and change in PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 23, 2002, at Special Order Volume 56, Page 2223, approving Transfer Application T-9230, supersedes Certificate 56259, State Record of Water Right Certificates.
