CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

L AND L FARMS  
PO BOX 69  
ECHO, OR 97826

confirms the right to use the waters THREE WELLS, in the SPIKES GULCH RIVER BASIN for PRIMARY IRRIGATION OF 5.5 ACRES AMD , SUPPLEMENTAL IRRIGATION OF 475.5 ACRES.

This right was perfected under Permit G-8570. The date of priority is APRIL 19, 1979. This right is limited to not more than 6.01 CUBIC FEET PER SECOND (CFS), BEING 2.0 CFS FROM WELL 1, 2.01 CFS FROM WELL 2, AND 2.0 CFS FROM WELL 3; or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


This certificate describes that portion of water right Certificate 75121 as modified by Transfer T- 9845. The changes in PLACE OF USE and CHARACTER OF USE were confirmed by an order of the Water Resources Director recorded in Special Order Volume 77, Pages 129-130. This certificate also describes that portion of water right Certificate 75121 as modified by Transfer T- 10251. The change in PLACE OF USE was confirmed by an order of the Water Resources Director recorded in Special Order Volume 80, Pages 275-276.

In addition, this Certificate includes the portion of the originating water right Certificate 75121, NOT modified transfers T-9845 and T-10251. This certificate supersedes Certificate 75121.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
