confirms the right to the use of water perfected under the terms of Permit G-2279. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: FOUR WELLS, TRIBUTARIES OF WILLAMETTE RIVER

PURPOSE OR USE: MUNICIPAL USE

MAXIMUM RATE: 0.56 CUBIC FOOT PER SECOND (CFS), FURTHER LIMITED TO NO MORE THAN 0.25 CFS FROM RIVERDRIVE WELL

DATE OF PRIORITY: OCTOBER 15, 1962

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose aforesaid is restricted to the lands or place of use herein described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm changes in POINT OF APPROPRIATION, PLACE OF USE, and CHARACTER OF USE approved by an order of the Water Resources Director entered JULY 6, 2017, at Special Order Volume 105, Page 202, approving Transfer Application T-12261, supersedes Certificate 31510, State Record of Water Right Certificates.
