CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

H. B. AND MELBA L. GERMOND 6894 HUBBARD CREEK RD UMPQUA, OR 97486

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of HUBBARD CREEK, for the purpose of the IRRIGATION of 5.4 ACRES AND DOMESTIC USE FOR ONE FAMILY.

This right has been perfected under Permit S-48060. The date of priority is SEPTEMBER 20, 1983. The right is limited to not more than 0.029 CUBIC FOOT PER SECOND; BEING 0.024 CFS for IRRIGATION AND 0.005 CFS for DOMESTIC USE, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 ACRE-FEET PER ACRE for each acre irrigated during the irrigation season of each year.

The use shall conform to such a reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
