 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALDER SLOPE DITCH COMPANY
 ENTERPRISE, OR

confirms the right to use the waters of HURRICANE CREEK, a tributary of WALLOWA RIVER for IRRIGATION of 3407.1 ACRES, DOMESTIC and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 140-143. The date of priority is 4:00 p.m., NOVEMBER 30, 1901.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season..


