confirms the right to use the waters of UMATILLA RIVER, tributary to COLUMBIA RIVER for SUPPLEMENTAL IRRIGATION of 25.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1910.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.32 CUBIC FOOT PER SECOND, SUBJECT TO THE PROVISIONS OF PARAGRAPH 33 OF SAID DECREE, or its equivalent in case of rotation, measured at the point of diversion.

This certificate describes that portion of water right Certificate 2554 as modified by Transfer T-2554. The change in PLACE OF USE was confirmed by an order of the Water Resources Director recorded in Special Order Volume 77, Pages 129-130. This certificate, together with Certificates 80397 and Certificate 88627, supersedes Certificate 2554.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
