CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ANDERSON CREEK and RESERVOIR CONSTRUCTED UNDER APPLICATION NO. R-20521, PERMIT NO. R-801, a tributary of SWAN LAKE for IRRIGATION of 81.6 ACRES.

This right was perfected under Permit S-21482. The date of priority is JUNE 12, 1952. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.02 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-801, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


