confirms the right to the use of water perfected under the terms of Permit S-3356. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: DRAKE CREEK AND REAM'S RESERVOIR, CONSTRUCTED UNDER PERMIT R-398, TRIBUTARIES OF CROOKED RIVER

PURPOSE OR USE: IRRIGATION OF 9.0 ACRES

MAXIMUM RATE: 0.11 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 9, 1917

The point of diversion is located as follows:

The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (if for irrigation, or any other purpose), is as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for any purpose is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered OCTOBER 28, 2019, at Special Order Volume 114, Page 276, approving Transfer Application T-12990, supersedes Certificate 89789, State Record of Water Right Certificates.
