CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-5582. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: CROOKED RIVER, A TRIBUTARY OF THE DESCHUTES RIVER

PURPOSE OR USE: IRRIGATION OF 14.4 ACRES

MAXIMUM RATE: 0.181 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JULY 27, 1922

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
16 S	19 E	WM	34	SW NE	POST DITCH - 1510 FEET SOUTH AND 520 FEET EAST FROM N1/4 CORNER, SECTION 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:


The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
