confirms the right to the use of water perfected under the terms of Permit G-7322. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELLS 1, 5, 6 AND 7 IN THE EAST FORK LITTLE PUDDING RIVER BASIN

PURPOSE OR USE: IRRIGATING 281.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 10.2 ACRES

MAXIMUM RATE: 3.64 CUBIC FEET PER SECOND (CFS); BEING 1.21 CFS FROM WELL 1, 2.43 CFS FROM WELL 5, 1.0 CFS FROM WELL 6 AND 1.64 CFS FROM WELL 7

DATE OF PRIORITY: MARCH 17, 1977

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same lands.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional points of appropriation (Wells 6 and 7), together with the quantity diverted at the original points of appropriation (Wells 1 and 5), shall not exceed the quantity of water lawfully authorized for the authorized points of appropriation.


When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered April 23, 2003, at Special Order Volume 57, Page 503, approving Transfer Application T-9287, supercedes Certificate 65869, State record of Water Right Certificates.
