CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-36801. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: GREASY CREEK AND MILTS POND, CONSTRUCTED UNDER APPLICATION NO. R-50764, PERMIT NO. R-5972, A TRIBUTARY OF MARYS RIVER

PURPOSE OR USE: FISH CULTURE AND IRRIGATION OF 0.5 ACRE

MAXIMUM RATE: 0.016 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM GREASY CREEK AND RESERVOIR FOR FISH CULTURE AND 0.006 CFS FROM GREASY CREEK FOR IRRIGATION

DATE OF PRIORITY: JUNE 28, 1973

The points of diversion are located as follows:

13 S	6 W	WM	6	SW NE	RESERVOIR (ORIGINAL)- 2280 FEET SOUTH AND 470 FEET EAST FROM N1/4 CORNER, SECTION 6

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 FOR IRRIGATION acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5972.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The water user shall maintain the headgate, to control and regulate the quantity of water diverted, as required by the Department.

The water user shall operate and maintain an approved fish screen at the point of diversion. If Oregon Department of Fish and Wildlife (ODFW) determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described and is subject to the existing minimum flow policies established by the Water Policy Review Board.

This certificate is issued to confirm a change in POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered October 23, 2014, at Special Order Volume 93, Page 752 and Special Order Volume 93, Page 853, approving Transfer Application T-11495, supercedes Certificate 42989, State record of Water Right Certificates.
