## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ADELBERT EVERS RT 1 BOX 299 A FOREST GROVE, OR 97116

confirms the right to use the waters of a SMALL DRAINAGEWAY AND RESERVOIR, constructed under Permit No. R-5991, a tributary WEST FORK DAIRY CREEK, for IRRIGATION of 33.95 ACRES and SUPPLEMENTAL IRRIGATION OF 5.30 ACRES.

This right was perfected under Permit S-36903. The date of priority is MAY 12, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.49 CUBIC FOOT PER SECOND (CFS), being 0.42 for IRRIGATION and 0.07 CFS for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5991. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
